Consequent upon completion of tenure of the Managing Committee of Federal Employees Cooperative Housing Society, Islamabad on 12-03-2014, the Managing Committee of the Society deemed to be dissolved under Byelaws No. 31(2). However, the Honourable Civil Court of Islamabad had granted status quo order on 27-03-2014 till next date of hearing with regard to appointment of Administrator of the Society, conducting of Audit and AGM of Society. However, the status quo was not extended by the Civil Court of Islamabad on next date of hearings on 31.03.2014, 15.04.2014 and 18.04.2014. The fresh elections of the Society will be held on 15-06-2014. The Managing Committee of the Society is hereby dissolved under Byelaws No. 31(2) and Mr. Kamran Ali Cheema, Magistrate (City), Islamabad is hereby appointed as Administrator of the Society, till holding of fresh elections of Society. The matter was also discussed during the course of hearing before the Deputy Commissioner / Registrar Cooperative Societies, Islamabad held on 20-05-2014 in the light of directions of the Honourable Islamabad High Court Islamabad vide order dated 09-05-2014 in a Writ Petition No. 2251/2014 titled "Muhammad Naveed Alam VS Chief Commissioner, Islamabad". The petitions referred above in the writ petition were disposed of by the Deputy Commissioner / Registrar Cooperative Societies, Islamabad with the decision to appoint Administrator of the Society as the tenure of present Managing Committee is expired and holding of elections on 15-06-2014.
