Learned counsel for the FECHS alongwith Secretary of the Society has submitted summary of allotment of Jinnah Garden Phase-I and Jinnah Garden Phase-II alongwith seniority list duly approved by the AGM which has been placed on record. He further contends that layout plan of the Society has been approved and now matter is pending for issuance of NOC. It is further contended that as per approved layout plan 2311 plots have been created and there is likelihood after completion of development work same will be allotted. It has further been contended that total pending list of allottee is 5527 of all the categories Including commercial. The Secretary of the Society has assured the Court that as per available assets respondent Society will purchase further land and thereafter all the allottees shall be accommodated though original allotment were given beyond the available land by the respective executive committee in the previous years for which separate FIRs have been lodged against the delinquents who are facing trial.

2. Keeping in view of above position it is expected from the competent authorities of the Society that they will not violate the seniority list duly notified by AGM. At this stage learned counsel for the petitioner contends that he feels satisfied on the statement of the Secretary of the Society, therefore, instant writ petition stands disposed of with the observation that respondent Society will allot the plots in accordance with the seniority list.
